JooJoo | Fountain Valley Regional Hospital and Medical Center, Orange County

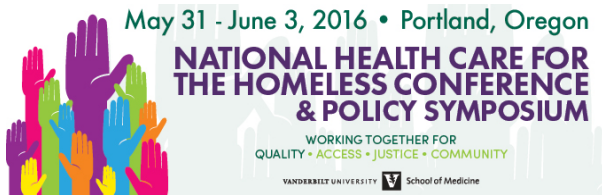

Care for the Homeless Conference & Policy Symposium to present a poster on our Chronic Care Plus (CCP) program. This pilot program aimed to chart a path to stability for the medically vulnerable homeless. Illumination Foundation partnered with St. Joseph Health to take those who were high utilizers of the emergency room and place them into post-hospital Recuperative Care coupled with permanent supportive housing. The aim was to provide full spectrum of care to break the cycle of hospital recidivism and homelessness.
